RE: 5/29/13 Letter; Invitation to meet with our 6 FAIA AE911Truth members

Dear Mr. Stephens (and President Jacob, Board members):

Thank you for your frank response regarding our request for explanation.

While we agree with the AIA's authority over its website we stress, in no uncertain terms that when additional facts turn up in a case that calls into question or disproves a prior conclusion, it is incumbent on those involved to re-examine the original evidence in light of the new evidence, and if necessary, change the original conclusion.

In this case, we have found a deliberate attempt on the part of a government agency, NIST, to misinform the public and, inadvertently, cast design professions as incompetent. If the situation was reversed and you as an attorney found yourself on the receiving end of such dispersions and misleading statements, I doubt you would sit by and say nothing to protect the integrity of your profession.

The NIST investigation and subsequent Final Report of 2004 is, at best, a slap in the face to the families and victims of the disaster in New York and to the World at large. At its worst, it is a deliberate attempt to discredit the Architectural and Engineering Professions and mislead the public away from the actual cause of the destruction of three World Trade Center high-rises.

We have therefore assembled and attached a brief Overview and Summary of the WTC evidence for the AIA President and Directors.

We have been encouraged to come to this year's conference and to host a speaking event – for which we are grateful. It would be in the AIA's best interest for its leadership to become aware of the evidence and of our position.

We therefore invite you to attend the 90 minute live presentation of the evidence on Friday night at 7pm in Room #110 at the Convention Center. Please also feel free to stop by our exhibit booth #1355 and discuss the issues. We would like to extend a challenge to each of you who feels certain that the official story is still a reasonable explanation.
